# Rotary Model United Nations Permission Slip

## Authorization and Release

I am the parent/guardian of the student listed above, and hereby authorize and consent for my child to participate in the Rotary Model UN Training Session and Conference noted above. I acknowledge that these Rotary Model UN events do not include any activities outside the Site venue, including without limitation all transportation of my child to and from the Site for the Training Session and the Conference, and the arrangements, if any, for my child to stay at the Hampton Inn Del Mar hotel for the Conference (“Hotel”). I am responsible for arranging transportation of my child to and from the Site for the Training Session and the Conference. I further acknowledge that I have been advised by the Rotary Model UN Committee, and I hereby agree, that if my child will be staying at the Hotel, that my child cannot stay at the hotel by themselves, and that either I, their Model UN Advisor or another adult whom I have authorized will stay overnight at the Hotel to supervise my child at all times and to ensure the health and safety of my child while staying at the Hotel.

I agree not to hold the Rotary Model United Nations Committee members, any sponsoring Rotary Club or its members, my child’s Rotary Model UN Advisor, Rotary International, Rotary District 5340 and/or the City of Del Mar liable for any expense or injuries that my child may incur or cause while attending these events or staying at the Hotel. I understand that my child is responsible for his/her/their own behavior at all times. If my child becomes involved in any behavior which presents a danger to himself/herself/themselves and/or others or is considered seriously inappropriate (e.g. general harassment, leaving the Site of the event, sexual harassment, sexual misconduct, use of drugs or alcohol, use of cigarettes, or participation in any illegal activities), one or more of the following steps may be taken: exclusion from participation in event activities, phone call to parent or legal guardian, and/or expulsion from the events. I understand that if my child causes damages at the Site or the Hotel, I will be charged and have to pay for such damages. If my child is asked to leave an event, I will be responsible for transportation charges incurred with early dismissal. I understand that I will be kept abreast of my child’s activities and behavior and will be aware of the situation before any action is taken. However, I realize that the District 5340 Rotary Model UN Committee will make the final decision in any action that involves my child irrespective of my opinion. I understand that the Model UN Committee reserves the right to handle the situation in any way that it deems appropriate and that will have the most positive result for the student and for the entire group.

I further authorize the Rotary Model UN Committee and/or Rotary District 5340 to act on my behalf for my child to obtain medical care, including medications and hospital care if necessary, for my child while he/she/they is participating in these Rotary Model UN events. I hereby give my consent to the medical providers selected by the Model UN Committee and/or Rotary District 5340 to evaluate, treat and hospitalize, if necessary, my child. In consideration of Rotary District 5340’s sponsorship of these Model UN events, I hereby assume the risk associated with my child’s participation in these Model UN events and irrevocably agree to release, indemnify, defend and hold harmless Rotary International, Rotary District 5340, the Rotary Model UN Committee members, any sponsoring Rotary Club or its members, my child’s Rotary Model UN Advisor, the City of Del Mar, and their respective trustees, directors, officers, employees, agents, representatives, successors and assigns from any and all liabilities, damages, claims, losses, lawsuits, expenses (including without limitation reasonable attorney’s fees and costs), or demands of any kind and nature whatsoever, whether or not a lawsuit or other proceeding is filed, that may arise out of or relate to the transportation of my child to and from the Site for any of these Model UN events, my child’s actions or participation at or around the Site or in any way related to these Model UN events, and/or my child’s actions or safety at or around the Hotel or otherwise associated with my child staying at the Hotel. This authorization/agreement shall serve as a full and complete general release and assumption of risk for my child, for his/her/their heirs, estates, executors, administrators and assignees, and for all members of my family.
